As a property owner, tenant, or person who has requested notice, please be advised that the Alameda County Solid Waste Local Enforcement Agency (LEA) received and approved an application to issue a new solid waste facility registration permit (SWFP) for Livermore Sanitation Recyclable Materials Transload Facility. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within Alameda County, including all active transfer stations, active landfills & closed landfills.

Description of Project and LEA's Determination

Livermore Sanitation Recyclable Materials Transload Facility (LSRMTF) is located at 7000 National Drive, in the City of Livermore, California. The Facility is located on the north side of National Drive between South Vasco Road and Greenville Road. The site is approximately 1.02 acres and the operating acreage for the facility is 1.02 acres.

On April 21, 2010, the Livermore Sanitation, Inc (LSI) submitted a request for a new registration permit application package for the LSRMTF to the LEA. In accordance to the California Codes of Regulations (CCR) Title 14 Section 18104.2, the LEA finds the Registration Permit Application meets the requirements of CCR Title 14 Section 18104.1 and is complete and correct. On May 21, 2010, the LEA approved the request for a new registration permit. The LEA hereby issues the Registration Permit to operate a solid waste Direct Transfer Facility.
