

Janitorial Cleaning Products Bid

Background

The County uses certified green cleaning products that perform comparably to traditional products while helping to create a healthy work environment for janitorial staff and building occupants. Specifying third party certifications such as [Green Seal](#), [EcoLogo](#), and the [U.S. Environmental Protection Agency's Design for the Environment \(DfE\) program](#) ensures that we receive products that achieve their claims of being environmentally preferable. Issuing the bid as a Request for Proposal allows us to evaluate the vendors based on best value. We evaluate bidders on product effectiveness (as field tested by our janitors), dispensing systems, customer service, and training plan.

II. STATEMENT OF WORK

A. INTENT

It is the intent of these specifications, terms and conditions to describe environmentally preferable janitorial cleaning products required by the Alameda County General Services Building Maintenance Department (GSA-BMD), Sheriff's Department and Probation Department.

The County intends to award a three (3) year contract (with option to renew) to the bidder(s) selected as the most responsible bidder(s) whose response conforms to the RFP and meets the County's requirements.

It is the intent of these specifications, terms and conditions to procure the most environmentally preferable products with equivalent or higher performance and at

equal or lower cost than traditional products. Specific requirements from the County's Sustainability Program related to this Bid are included in the appropriate Bid sections.

B. SPECIFIC REQUIREMENTS

1. Product Requirements:

a. Dispensers:

- (1) Dispensers will be required for some of the cleaning products, while for other products, it will be a desirable specification (please see Exhibit O – Products Specifications and Requirements). If none is stated, a dispenser is not desired by the County
- (2) All dispensers for the cleaning products must be closed dilution-control system dispensers, which automatically dilute concentrated products using water directly from the water pipes and prevent the concentrated product from being accessed by users.
- (3) All dispensers will be provided to the County at no additional cost.
- (4) Most dispensers will be installed by the General Services Agency (GSA) Building Maintenance Building (BMD). If installation is required by the vendor(s), this will be provided to the County at no additional cost.

b. Department Requirements

- (1) Sheriff's Department/Probation Department requires that:
 - (a) All cleaning products be in a tamper proof dispenser
 - (b) All dispensers be secured with a padlock in order to keep the cleaning products locked up and under control.
 - (c) All cleaning products be colored and be delivered with a corresponding colored rag/towel that is to be used with the product.

- c. All product requirements, specifications and any additional documentation are included in Exhibit O – Product Requirements and Specifications. The products included in this bid are divided into 8 product groups that are discussed in general terms in Exhibit O. Within each group there are specific cleaning products that the County uses for custodial purposes. **Bidders must bid all the products within a given**

Group, as specified, to be compliant with the bid requirements. In the case of carpet care and hard floor care, bidders must bid a comprehensive cleaning system to meet the County's needs. Bidders may choose to bid one or more groups of products. A high level summary of the product groupings and the requirements for bid are presented in Table 1 for clarification purposes on page 9 and 10.

d. Environmental Certifications:

For purposes of this RFP, the minimum standards established for the performance of environmentally preferable cleaning products are based on Green Seal and/or EcoLogo standards relevant to that category of products as specified under each product category listed in Exhibit O. The County strongly encourages vendors to offer products that also meet the desired specifications as listed under each product category. Products that meet the U.S. Environmental Protection Agency's (EPA) Design for the Environment program will also meet the minimum

environmental standard provided that the product has passed the third party audit process and can provide documentation as such at the time of bid submission.

Green Seal and the EcoLogo Program are independent organizations that strive to achieve a healthier and cleaner environment by identifying, certifying and promoting products and services that cause less toxic pollution and waste, conserve resources and habitats, and minimize global warming and ozone depletion. Design for the Environment (DfE) is a U.S. EPA program that utilizes scientific review teams to screen each ingredient for potential human health and environmental effects and allows for display of DfE logo on products that—based on currently available information, EPA predictive models, and expert judgment—contain only those ingredients that pose the least concern among chemicals in their class. The Green Seal, EcoLogo and Design for the Environment evaluations are based on state-of-the-art science and information using internationally recognized methods and procedures. For more details about the certification standards referenced in this RFP, see Exhibit P. e. Samples:

The bidders may be requested to furnish 5 gallon sized, in a ready-to-use dilution, sample of product(s) bid for examination by the County. Any product(s) so requested shall be furnished within five (5) business days from the date of request and furnished at no cost to the County and sent to the GSA-Purchasing Department.

f. Off/Non Contract Items:

Off-contract products are those products without fixed contract pricing. There are two (2) separate categories contained in Exhibit B2 for off-contract products linked to similar product categories contained in Bid Form Exhibit B and Exhibit B1. For example, if a bidder provides contract pricing for Exhibit B, Paper Products, then the same bidder is obligated to provide a guaranteed minimum fixed discount off of the bidder's catalog(s) prices stated for Paper Products that are not on-contract. This discount must be valid for the duration of any agreement, and will apply to any and all Coarse Paper Products and/or Liners ordered from the Contractor's catalog(s) whether they be in print form or items available for ordering online. Contractor shall provide County the maximum discount possible from their catalog list price to match or improve on competitor's retail prices for same exact product required by County. The primary objective is for each Contractor to provide its entire catalog(s) of products for the specific bid category they are awarded so that County

agencies may order a broad range of products as appropriate for their needs with exceptions noted as excluded items.

C. DELIVERABLES/REPORTS

2. Training:

a. The product manufacturer, their distributor, or a third party must offer onsite training and training materials in the proper dilution and use of products as well as the proper disposal of unused product. Specific attention will be paid to safety issues, emergency procedures, and how chemicals may or may not work together. Initial training and additional training during the contract term will be offered at no additional cost to the County. Components of the training program will include but not be limited to:

- (1) On-site initial training, up to thirty (30) hours, for use of products including field demonstrations for approximately 20 staff including Janitorial Supervisors, Leads, and other staff.
- (2) On-site training on an as needed basis, with specific staff, for the purposes of trouble-shooting particular issues. This training may need to occur in the evenings or early morning.
- (3) Training materials for Janitor Supervisors and Leads to train janitorial line staff. There are approximately 200 line staff janitors. Training material will be picture-based with English text. A description of the training approach and materials should be included in the bid response. Examples of training materials may be included.
- (4) Written instructions on the use of products and equipment. Instruction on how to properly maintain equipment will be addressed.
- (5) Training materials should include step-by-step instructions for the proper dilution, use, and disposal, and the proper use of dispensing equipment, if applicable.
- (6) On-going training, as needed, either on-site or at designated sites within the County.

3. Reports:

Contractor shall provide electronic quarterly usage reports to the GSA Sustainability Department and to the Purchasing Department Procurement Specialist for Janitorial Cleaning products at no cost to the County. **These**

reports shall be submitted in a Microsoft Excel electronic file and be formatted in such a way as to be sortable.

The County will work with the Vendor(s) to finalize the format of these reports upon contract award. The County reserves the right to make changes to the report and to request additional information if deemed necessary. These reports will be issued within three weeks of the close of the previous quarter. Electronic and/or hard copies of these reports shall be sent to additional County business units upon request. Ad hoc reports shall be provided by the Contractor as required at no additional cost. Below is a description of the minimum information that will be included in the report and the formatting requirements.

g. Detailed Quarterly Usage Report Formatting

- (1) Information provided in one worksheet (not multiple tabs or worksheets)
- (2) Formatted to sort chronologically by purchase date and by key categories as defined below
- (3) Each horizontal line to contain the data for a single transaction including item, quantity, unit cost, and total cost of transaction

h. Key Categories

- (1) Purchase date
- (2) Customer Number (provide key)
- (3) Item part number
- (4) Item description (e.g., brand, size, color, etc.)
- (5) Type of unit used for pricing (e.g., each, box)
- (6) Number of individual pieces per unit
- (7) Units purchased (i.e., order quantity)
- (8) Shipped quantity (if not same as order quantity)
- (9) Unit price (i.e., charge to customer)
- (10) Total order cost
- (11) Certification standard met by product, if any (e.g. Green Seal, EcoLogo or DfE- SSCP¹⁰).
